

PRODUCT DEFINITIONS

The following lamp shapes comprise most of the lamp market today, and therefore are the focus of this report. All consolidated data listed in this report includes only the shapes described below:

- A-lamps A17, A19, and A21 (A55, A60, and A66 where the metric system is used) - Diameter of bulb is 2.125 inches (55 mm) for an A17, 2.38 inches (60 mm) for an A19, and 2.63 inches (66 mm) for and A21 lamp. For the purposes of this report, lamps of other technologies may not fit these exact measurements, but are marketed and used as direct replacements (E.G. a spiral CFL)
- Reflector Lamps Use a device inside the lamp to redirect light by the process of reflection. Lamp types for this report include: PAR (Parabolic Aluminized Reflector); spotlights; floodlights; R, BR, and ER lamp shapes. Note: MR (Multifaceted Reflector) lamps are not included in this category.
- MR (Multifaceted reflector) Lamps Have a pressed glass reflector on the inside surface composed of facets and covered by a reflective coating. The reflective coating of MR lamps can be either dichroic or aluminum. In some regions, MR16 (50 mm diameter) lamps that use a GU10 socket are referred to as GU10 lamps. For the purpose of this report, all MR16 lamps, regardless of base, will be labeled as MR16 lamps.

PRODUCT DEFINITIONS

 T-Lamps: Are generally low-pressure discharge fluorescent lamps that consists of a glass tube coated with phosphors, trace amounts of mercury, and an electrode at each end of a tube. The tube can be linear, U-shaped, or circular. T-lamps are characterized by their diameter (T-designation) and length in inches. The T-designation is in terms of ¼-inch increments. For example, a T-5 lamp is 5 x ¼, or 5% inch in diameter; a T-12 is 12 x ¼, or 1½ inches in diameter. For the purpose of this report, SU is only taking into consideration T-5 through T-12 shipments for this report, as these are the most commonly used tube diameter sizes.
